



Healthy At Home Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN.

1. **CONTEST PERIOD:** The Ale-8 Healthy at Home Giveaway begins at **9:00:00 AM** Eastern Time (“EDT”) on **January 1, 2020** and ends at **11:59 PM EDT** on **January 31, 2020** (“Contest Period”).

2. **ELIGIBILITY:** The contest is open only to legal residents of the United States who are eighteen (18) years of age or older as of the date of entry. Void where prohibited or restricted by law, regulation, rule, or otherwise. Employees of Ale-8-One Bottling Company (“Sponsors”), its parents, affiliates, subsidiaries, and advertising and promotion agencies (aforementioned individuals and organizations collectively, “Contest Entities”), retailers, and the immediate family members (spouses and siblings, children and parents and their spouses, regardless of where they live) or members of the same households (whether related or not) of such individuals are not eligible.
